The warrantor, CALIMET CO., INC, warrants the above gate operators for a period of three (3) years in commercial installations and for a period of five (5) years in residential installation to be free from defects in circuitry, motor, gearbox and workmanship. This warranty applies from the date of purchase to the original owner. Warrantor will repair or, at its option, replace any device which it finds to require service, excepting that, this limited warranty does not cover the following: corrosion, damage or failures resulting from environmental conditions, vandalism, water, lack of proper maintenance, accident, theft, fire, normal wear and tear, misuse, alteration, tampering, improper repair, improper installation, installation of non-CALIMET approved parts, accessories, or components. This device must be sent to the warrantor at the consumer's expense to:
